

# **SolarWise Bonus Incentive Application**

# Instructions (Please do not submit instructions page with your application)

Considering "going solar"? Customers who participate in the EnergyWise No-Cost Home Energy Assessment Program may qualify for a Bonus Incentive for their solar energy generation under the RI Renewable Energy Growth (RE Growth) program if they reduce their energy consumption by at least 20%.

Existing solar PV installations are not eligible for the SolarWise Bonus. This Application must be submitted before, or with, the Interconnection Application.

# **SolarWise Application Process**

- 1. Use the SolarWise Bonus Incentive Eligibility Worksheet to determine your eligibility for SolarWise Tier 1 or Tier 2.
- 2. Complete any additional energy efficiency upgrades to meet your Energy Reduction Requirement.
- **3.** Complete the SolarWise Bonus Incentive Application.
- **4.** Submit your **<u>signed</u>** SolarWise Application and applicable Energy Efficiency Required Documents to National Grid via email (do not include instruction pages):
